The Ministry for Foreign Affairs of Iceland presents its compliments to the Ministry of Foreign Affairs of the Republic of Lithuania and has the honor to inform the latter that the Embassy of Iceland in Washington D.C. in the United States of America will start processing applications for a Schengen visa to Iceland on 3 February 2020. The Embassy of Iceland will open a Visa Application Centre in Chicago on 2 March 2020, thereby canceling Lithuania's representation in the handling of Schengen visa applications to Iceland in the United States of America from 1 March 2020.

The Agreement on Visa Representation between Iceland and the Republic of Lithuania, which entered into force on 1 March 2017, was concluded by the exchange of verbal notes from Iceland ref. UTN17010098/31.E.001, dated 15 February 2017 and Lithuania nr. 5-144/2017, dated 27 February 2017. With reference to the aforementioned Agreement, Iceland proposes that under the paragraph **Extent of representation**, the following text will be deleted from the agreement: -Chicago (United States of America);

If the foregoing proposal is acceptable to the Lithuanian side, the Ministry for Foreign Affairs of Iceland has the honor to suggest that the present verbal note and the corresponding note of acceptance will together constitute an Agreement between the Government of Iceland and the Government of the Republic of Lithuania on Visa Representation, which shall enter into force on 1 March 2020.

The Ministry for Foreign Affairs of Iceland avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Lithuania the assurances of its highest consideration.

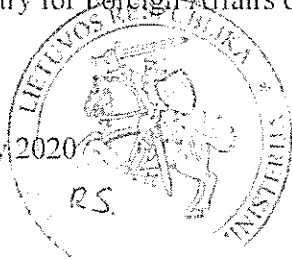
**Beginning of the quote.** The Agreement on Visa Representation between Iceland and the Republic of Lithuania, which entered into force on 1 March 2017, was concluded by the exchange of verbal notes from Iceland ref. UTN17010098/31.E.001, dated 15 February 2017 and Lithuania nr. 5-144/2017, dated 27 February 2017. With reference to the aforementioned Agreement, Iceland proposes that under the paragraph **Extent of representation**, the following text will be deleted from the agreement: -Chicago (United States of America);
