**NOTICE OF STOPPAGE OF AN OPERATION FOR THE MASTER**

Lodging the appeal does not suspend the stoppage of an operation. All costs relating to inspections carried out shall be charged to owner or operator of the ship. The stoppage of an operation shall not be lifted until full payment has been made or a sufficient guarantee has been given for the reimbursement of the costs.**
