AGREEMENT

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF LITHUANIA

AND

THE GOVERNMENT OF THE REPUBLIC OF INDONESIA

ON

THE EXEMPTION OF VISA REQUIREMENTS FOR HOLDERS OF

DIPLOMATIC AND SERVICE PASSPORTS

The Government of the Republic of Lithuania and the Government of the Republic of Indonesia, hereinafter referred to as "the Parties";

Considering the friendly relations between the Parties;

Desiring to further strengthen their friendly relations and cooperation, on a reciprocal basis, by facilitating the entry of holders of diplomatic and service passports of the Republic of Lithuania and the Republic of Indonesia into their respective countries;

Pursuant to the prevailing laws and regulations of the respective countries;

Have agreed as follows:

Article 1 VISA EXEMPTION

- 1. Nationals of the Republic of Indonesia, holders of valid diplomatic or service passport, shall not be required to obtain a visa to enter, transit and stay in the territory of the Republic of Lithuania. Each period of stay shall not exceed 30 (thirty) days from the date of entry. However, the total period of stays shall not exceed 90 (ninety) days in any period of 180 (one hundred and eighty) days.
- 2. Nationals of the Republic of Lithuania, holders of valid diplomatic or service passport, shall not be required to obtain a visa to enter, transit and stay in the territory of the Republic of Indonesia for a period of stay not exceeding 30 (thirty) days from the date of entry.
- 3. The above-mentioned exemption of visa requirements is not applied to the nationals of the State of either Party, who are holders of valid diplomatic or service passports, to take any gainful activities in the State of the other Party.

Article 2

VISA FOR MEMBERS OF DIPLOMATIC OR CONSULAR MISSION

Nationals of the State of either Party, who are holders of valid diplomatic or service passports and assigned as members of diplomatic missions or consular posts as well as representatives of international organizations, located in the territory of the State of the other Party, including their family members, shall be required to obtain appropriate entry visa prior to their entry.

Article 3 ENTRY AND EXIT CONDITIONS

- 1. Nationals of the State of either Party, holders of valid diplomatic or service passports mentioned in Article 1 of this Agreement, may enter and leave the territory of the State of the other Party at any border crossing points designated for international passenger traffic.
- 2. The Parties shall inform each other immediately of any changes in their respective laws and regulations governing the entry and stay of foreigners.

Article 4 DURATION OF PASSPORT VALIDITY

The duration of passport validity of nationals of the State of either Party shall be at least 6 (six) months before entering the territory of the State of the other Party.

Article 5 THE RIGHTS OF AUTHORITIES

- 1. This Agreement shall not exempt nationals of the State of either Party, holders of diplomatic or service passports, from the obligation to respect the laws and regulations enforced in the territory of the State of the other Party.
- 2. This Agreement does not affect the right of the competent authorities of the State of either Party to refuse admission or to shorten the stay in its territory of nationals of the State of the other Party, specified in Article 1 of this Agreement, who are considered undesirable or likely to endanger public peace, public order, public health or national security.

Article 6 SUSPENSION

- 1. Either Party may temporarily suspend, partly or entirely, the implementation of this Agreement for reasons of national security, public order or public health.
- 2. The other Party must be notified in advance in writing through diplomatic channels about the suspension and re-entering into force of this Agreement. The implementation of the suspension and termination of suspension of this Agreement shall enter into force thirty 30 (thirty) days from the date of the receipt by the other Party.
- 3. The suspension of the implementation of this Agreement shall not affect the rights of nationals, mentioned in Article 1 of this Agreement, who are already staying in the territory of the receiving State.

Article 7

SPECIMEN AND ISSUANCE OF PASSPORTS OR TRAVEL DOCUMENTS

- 1. The Parties shall exchange specimens of their diplomatic and service passports through diplomatic channels within 30 (thirty) days from the entry into force of this Agreement.
- 2. In case of introduction of new diplomatic or service passports, as well as modifications to the existing ones, the Parties shall transmit the specimens of the said passports and inform about any changes, to each other in writing, through diplomatic channels not later than 30 (thirty) days prior to their official introduction.
- 3. In case of a national of the State of either Party loses or damages his or her valid passport in the territory of the State of the other Party, he or she shall immediately inform the competent authorities of the receiving Party, through diplomatic mission or

consular post of the country of his or her nationality, for appropriate action. The diplomatic mission or consular post concerned shall issue to the aforementioned national a new passport or travel document for returning to the country of his or her nationality, in conformity with the legislation of his or her country.

Article 8 AMENDMENTS

This Agreement may be amended only by mutual written consent of the Parties. Such amendment shall enter into force according to the provision of Article 10, paragraph 1 of this Agreement, and shall form an integral part of this Agreement.

Article 9 DISPUTES SETTLEMENT

Any difference or disputes arising between the Parties on the implementation or interpretation of this Agreement shall be settled amicably through consultations and/or negotiations between the Parties through diplomatic channels.

Article 10 ENTRY INTO FORCE, DURATION AND TERMINATION

- 1. This Agreement shall enter into force 30 (thirty) days from the date of the receipt of the last written notification in which the Parties inform each other, through diplomatic channels, that all requirements for the entry into force of this Agreement, as stipulated in their respective internal procedures, have been fulfilled.
 - This Agreement shall remain in force for an indefinite period of time.

3. Either Party may terminate this Agreement by giving written notification to the other Party through diplomatic channels. The termination shall take effect 90 (ninety) days after the date of the receipt of the written notification of termination by other Party.

In witness whereof the undersigned being duly authorized, have signed this Agreement.

Done in Jakarta on Thursday, 27 August 2015, in two originals, each in the Lithuanian, Indonesian and English languages, all texts being equally authentic. In case of any divergence in their interpretation, the English text shall prevail.
